WHAT IS PRIMAL THERAPY?

Saturday, February 19, 1977, Joe Sanders, Tom Rose, Alice Rose, Ninalee May, Alec Rubin, Diane Timon, Armand DiMele, Constance Corey, Victor Zeines and Charlotte Saunders presented a panel discussion at the Florida Keys Community College, Key West, Fl., on "What is Primal Therapy?" Sixty-nine enthusiastic attendees got a two hour mini introduction to Primal Therapy. It was a rewarding experience for all of us.

A war between shrinks is being waged in the courts over who owns the name "Primal." On one side, the father of Primal Therapy, Arthur Janov, Ph.D., says he does. In 1970 he registered the name with the U. S. Patent Office. Since then he's had his attorneys sue two therapists and warn 75 others not to describe their work as "Primal." The International Primal Association - with a membership of 250 therapists-obviously disagrees with Janov's position. This week, the IPA began giving depositions at the federal patent agency in Boston challenging Janov's trademark.

"No one owns the name "Primal." said Armand DiMele, president of the IPA, last week in an interview. "We've found the name used by Freud and Reich. It's like owning the work "analysis." It's not right to patent a word that's a process."

"It's a free country." Dr. Janov told us in response. People can do what they want. But why don't they make up their own name? What the hell do they want my name for?"

The IPA was formed in 1973, according to DiMele, by primal therapists who had broken away from Janov. "He wanted to control the whole thing." said DiMele. "Even if you trained with him, he disclaimed any connection with you. Which I can understand from a business point of view. Janov's a good businessman."

Michael Painter, Janov's lawyer, made similar accusations against the IPA. "It all comes down to money. They make a great deal of money claiming to possess what we developed. You can classify it as a monumental rip-off."

DiMele rejoinered: "Janov claims the techniques of Primal are secrets of his own. It's not a Janovian method. It's just an intense-feeling process that falls under the name Primal. We have our own standards. We have frequent board meetings, conventions, our own journal. We just want to share the information."

That's just what worries Janov: "Primal therapy is a specific modality developed over a period of 10 years that is highly dangerous in untrained hands," he said. "We've seen absolute basket cases, suicides, and psychoses resulting from mock Primal therapists. It takes three to five years to train a Primal Therapist. That's why we only have around 20 therapists in my institute."

"All analysis and, for that matter, biofeedback and hypnosis, are dangerous in the wrong hands," conceded DiMele, "But we have a right to take this process and develop it as we see it. And, besides, the result of our work-the Primal Man-isn't supposed to be into owning things."
